The National Animal Control Association will be conducting a Euthanasia Certification Workshop on October 24, 2011. This workshop is a "hands on" training program designed for Animal Control Officers, euthanasia technicians, shelter veterinarians and anyone else responsible for humane animal euthanasia.

The Program:

The program will be conducted on Monday, October 24, 2011, 7:30 a.m. – 6:00 p.m.

Topics of this course include:

Goals of humane euthanasia; History of euthanasia; Anatomy and physiology; Pharmacology of SP; Routes of administration; Restraint techniques; Sedatives; IV and IP techniques; Special problems; Stress management; Legal and regulatory issues; Hands on lab.

The Instructor:

The program will be taught by Dr. Keith Branson, D.V.M. Dr. Branson is a Clinical Assistant Professor of Anesthesiology at the University of Missouri, College of Veterinary Medicine. He has been in this position since 1992 and is Board Certified by the American College of Veterinary Anesthesiologists.

Location:

The program will be held at the Chilkat Center, located at 1 Theater Drive in Haines, Alaska. The phone number for the Chilkat Center is 907-766-3573.
