The National Animal Control Association was formed in 1978 for the purpose of assisting its members to perform their duties in a professional manner. NACA believes its most important contribution towards solving our domestic animal problems is to make available to Animal Control personnel a comprehensive training program.

Who Should Attend

This program is designed for Animal Control Officers at the federal, state, and local levels, Police Officers, and Sheriff's Deputies responsible for animal control and all of its many facets. In addition, those people interested in a career in the animal control/care field are welcome to attend. No previous animal control experience is required. It is **not** necessary to attend Level 1 or Level 2 before Level 3.

Tuition/Registration/Payment

Tuition for this program is \$575.00 for the full week of training (this represents a savings of \$220.00 over taking the individual workshops at the normal tuition rate). Tuition for individual workshops is as follows: Euthanasia, \$255.00; Chemical Capture, \$255.00; Bite Stick, \$180.00; OC Spray, \$105.00. Each workshop will require the successful completion of a written examination and a practical familiarization (hands-on use) for certification. Participants will be awarded certificates of completion by the National Animal Control Association.

The Level 3 Program

The NACA Level III program will consist of four different Certification Workshops done in a week-long format. This format will enable an officer to attend the entire week to obtain the four certifications or attend individual workshops as may be needed by the individual officer. The workshops included are:

Euthanasia Training: This two-day workshop will cover the History of Euthanasia, Goals of Humane Euthanasia, Anatomy and Physiology, Types of Administration, IV Technique, Stress Management, Legal and Regulatory Issues and Hands-on Lab Techniques using Anatomically correct animal models.

Oleoresin Capsicum Aerosol (Pepper Spray) Training: This four hour workshop will cover the History of Oleoresin Capsicum, Effects of OC, Proper Use and After Use Guidelines, Use of Force Considerations, U.S. State and Local Regulations, and Practical Training Exercises. (Certification does NOT require exposure to OC).

To register for this program, we ask that you first call our office at 913-768-1319 (press option 6). Send your original completed registration form (located on the back) to our office by **July 20, 2012 with payment**. You may pay for this program either with **Agency Check, Purchase Order Number or by Credit Card (Visa, MasterCard, AMEX, Discover)**. A **20% nonrefundable fee will be assessed on any cancellation made after July 20, 2012**.

NOTE: Programs are subject to cancellation, without sufficient registrations, 30 days prior to program start.

The Level 3 Program

Chemical Immobilization: This day and half workshop will cover Chemical Immobilization Policy Development, Legal Considerations and Record Keeping, Physiological Effects of Chemical Agents, Proper Dosage and Administration Techniques, Post-Immobilization Procedures, Public and Personnel Safety and the Use of Chemical Immobilization Equipment to include Range time practicing with that equipment.

Tactical Baton (Bite Stick) Training: This one day workshop will cover the History, Nomenclature and Design of the Tactical Baton, Primary Tactical Uses Against Animal and Human Attacks, Use of Force Continuum and Officer Liability Issues, Use of Force Reports, and Practical Application Exercises. (Batons will be provided for use during the training).

REMEMBER: Register for the entire week to save over \$220.00 in tuition!

Location and Lodging

The school will be conducted in **Kansas City, Missouri** at the **Best Western PLUS KCI Airport-East, located at 11130 NW Ambassador Drive in Kansas City**.
